RULES & TERMS

1. Specific protection must be worn at all times and compulsory protection for includes compulsory helmet and additional protection knee and elbow (see RELEASE further on). Highly Recommended protection includes tail bone or mid body pads and wrist. It is up to you to ensure that protection is fit for the purpose and is properly fitting, staff can advise and will check but it is entirely up to you to ensure the rules are met. Protection maybe available for hire but availability in busy times cannot be guaranteed.
2. You must take care when using the ramps and when there is more than one person using any individual ramp at any one time only one person may be permitted to drop in at a time.
3. You agree and accept that we will be monitoring and recording the skate area and this footage and copyright to it will solely be held by us and that we may use this footage for promotional purposes in all forms of media.
4. Spectators may NOT view in the skate area but they agree and understand that there is an element of risk in the viewing area and you agree and accept that you are entering the premises at your own risk.
5. NO Reckless behaviour, NO Smoking, NO Alcohol or intoxicated people are permitted in PARK DX, NO Food or drinks in the skate area or brought onto premises, NO Glass receptacles are permitted in the skate area, NO illegal substances maybe brought into the Park, NO weapons, NO Animals except guide dogs for blind, NO personal modifications maybe made by you to the skate area, NO lude or obscene gestures or behaviour in the Park, NO Cameras or Video recording devices are permitted to be used without our permission, other than by us, NO Child under the age of 12 maybe left in the Park without constant parental/guardian supervision.
6. Usage of the ramps is subject to you being a fully paid up member, paying the current rate of usage, wearing adequate protection, availability and signing of waiver, Release (if applicable) and these Rules and terms.
7. The maximum number of users permitted will be posted on site and in busy times may vary at our discretion. All users must be considerate of other users and "fair in usage" at all times to be decided by us.
8. We confirm that your details of membership will be held in paper and on computer and only used to advise of any changes of terms and conditions within Park DX. We reserve the right to alter without notice and to advise of any special events that maybe of interest to you from us alone. You may write to us to be removed from this list.

WAIVER

The following Authorization, Release and Indemnity form is a legally binding agreement. Please read it carefully before signing it.

In consideration for Park DX, Xtreme Adrenalin Ltd T/A Demon Xtreme Sports and their directors, officers, employees, agents, insurers and volunteers (collectively referred to as Park DX) permitting the member referred to in this document (the ≥Participant≤) to enter upon the premises of and use/spectate Park DX and to participate in the programs and activities offered at Park DX, I agree to the following on my own behalf and on behalf of the Participant and on behalf of our heirs, executors, successors, representatives and assigns.

1. I warrant that I am the person legally entitled to make decisions with respect to the care and the affairs of the Participant. I warrant that I am entitled to enter into this agreement on my own behalf, on behalf of the Participant and on behalf of any other parent or guardian of the Participant.
2. I understand that this agreement applies to facilities operated by and programs offered by Park DX. I understand that this agreement applies whether the Participant is an observer, a bystander or an active participant and whether the Participant is at any premises owned or occupied by Park DX, on an outing or activity sponsored by Park DX or travelling to and from such premises or outing.
3. I understand that skateboarding, skating, BMX, Heelys and Scooter or use of the ramp area can be dangerous and can result in injury, death or personal property damage to participants and to others.
4. I grant permission to the Participant to attend at the premises of Park DX, to use Park DX facilities and equipment and to participate in the programs and activities offered by Park DX.
5. In granting permission to the Participant to enter upon the premises of and use Park DX and to participate in the programs and activities offered by Park DX, I accept the condition of the ramps, equipment and other facilities and property and I accept that the condition could change to become more hazardous.
7. I understand that the Participant must obey and show respect for the rules and regulations of Park DX, and I undertake sole responsibility to advise the Participant of the necessity to do so.
8. On behalf of myself, the Participant, any other parent or guardian of the Participant and our heirs, executors, successors, representatives and assigns, I release Park DX from any liability, claim, action, suit or demand whatsoever which may arise in connection with or during the participant/s attendance at the premises of Park DX, his/her use of Park DX facilities and equipment and his/her participation in the programs and activities offered by Park DX. Without limiting the generality of the foregoing, this release shall apply to any liability, claim, action, suit or damage caused by the negligence of Park DX, the condition of the equipment or the premises or the actions of third parties.
9. I agree on my own behalf, on behalf of any other parent or guardian of the Participant and on behalf of the Participant to indemnify Park DX and hold it harmless against any liability, claim, action, suit or demand directly or indirectly whatsoever which may arise in connection with or during the Participant/s attendance at the premises of Park DX, his/her use of Park DX facilities and equipment and his/her participation in the programs and activities offered by Park DX. Without limiting the generality of the foregoing, this indemnity shall apply to any liability, claim, action, suit or demand for personal injury, death or property damage, including injuries, death or damage caused by the negligence of Park DX, the condition of the equipment or the premises or the actions of third parties. This indemnity shall include indemnification for any judgment, and for all costs incurred by Park DX in connection with litigation.
10. I agree on my own behalf, on behalf of any other parent or guardian of the Participant and on behalf of the Participant that we will not take legal action against Park DX or against any third party who may claim contribution or indemnity from Park DX with respect to any liability, claim, action, suit or demand whatsoever which may arise in connection with or during the participant/s attendance at the premises of Park DX, his/her use of Park DX facilities and equipment and his/her participation in the programs and activities offered by Park DX. Without limiting the generality of the foregoing, this agreement not to take legal action shall apply to any claim, action, suit or demand for personal injury, death or property damage, including injuries, death or damage caused by the negligence of Park DX, the condition of the equipment or the premises or the actions of third parties.
11. I acknowledge that Park DX may, at its discretion, revoke the Participant/s privileges to attend at the premises of Park DX, to use Park DX facilities and equipment and to participate in the programs and activities offered by Park DX and that Park DX will not be obliged to refund any monies in such cases.
12. Park DX reserve the right to close the facility at any point (private bookings, functions, events or purely under the discretion of the staff)
13. In the event that it appears to Park DX that the Participant requires medical or dental attention, testing or treatment (referred to as ≥Treatments≤) of any kind while using Park DX facilities and equipment or participating in the programs and activities offered by Park DX, I authorize Park DX to provide or to arrange for the provision of such Treatment and to consent to such Treatment on behalf of the Participant and myself as Park DX in its discretion considers advisable. RELEASE FROM WEARING ADDITIONAL PADDING
